## Vertix Asia-Pacific Pte Ltd, Web Earth Pte Ltd, and Ramboll Environ Singapore Pte Ltd become Ramboll, with a new legal name, registered address, UEN number and bank details, effective 1 February 2023

We are pleased to share that as of 1 February 2023, Vertix, Web Earth and Ramboll Environ will become fully integrated under the Ramboll brand. As part of this integration, Vertix Asia-Pacific Pte Ltd, Web Earth Pte Ltd, and Ramboll Environ Singapore Pte Ltd will be amalgamated into Ramboll Pte Ltd, effective 1 February 2023.

With the best of the respective work practices increasingly embedded across our disciplines, our team continues to provide high quality capabilities. This is now further enhanced by coming together as One Ramboll organisation with more integrated services. Over the coming months, we will reach out to you to explain more about this.

With the amalgamation, we will use a new UEN number and a new Ramboll Pte Ltd bank account, as well as a new registered office address. The team will move together into this new regional headquarters in Singapore in end February together with the other Ramboll companies.

The new registered office address will also apply to Ramboll Singapore Pte Ltd and Ramboll Studio Dreiseitl Pte Ltd. On 1 April 2023, Ramboll Studio Dreiseitl will become part of Henning Larsen, creating a dedicated Landscape Architecture team within the company. Henning Larsen, an international studio for architecture, landscape, and urbanism, became part of the Ramboll Group in 2019, with a shared ambition to be the partner for sustainable change. As this is a legal amalgamation, the contractual obligations and liabilities are automatically transferred to the surviving entity, Ramboll Pte Ltd. Consequently, any existing contracts with Vertix Asia-Pacific Pte Ltd, Web Earth Pte Ltd, and Ramboll Environ Singapore Pte Ltd will be carried forward unchanged to Ramboll Pte Ltd. Legally there is no need for executing any formal contract amendments, but further documentation can be provided upon request.

Please note that there has been no change in the company's management, your point of contact in our company and the services we offer to you. Please rest assured we will continue to deliver our projects according to contractual terms and to the highest quality that you are accustomed to.
