Description of the partnership	The partnership started with bilateral meetings in February to get to know the main priorities of the paired cities. During the kick-off meeting on 24th February, the topic of waste was clearly highlighted as the main area of cooperation. In eThekwini, employment through circular economy is a priority area. The second online meeting took place on 29 March 2022. The South African Delegation visited Porto from the 7-10 June 2022. This was followed by a Visit to Durban by the Porto Delegation from 17 – 21 October 2022.
